SUBJECT: -Extension of General Affiliation up to Senior Secondary Level .

This is with reference to school application on the subject cited above. In this connection, I am directed to convey the approval of the Board for Extension of General Affiliation as per details given below:-

The school is directed to ensure SI. No. that:

- The total number of sections of the 1 school shall be restricted to 22 of which not more than 1/3rd sections may be used for senior secondary classes. Number of students shall be restricted 32 in 16 sections. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law.
- 2 Some part of the school's boundary wall is appearing to be shared with adjacent wall. Thus, the school is directed to ensure that the school should be bounded from all sides with minimum 6 ft of height and submit the videography covering the entire boundary from all sides in continuity along with aerial view within 03 months and submit the compliance.
- 3 As per the videography, some part of the school is under construction. Thus, the school is directed to restrict the students entry in the construction area in view of safety of student.
- 4 The school has uploaded Building safety certificate wherein, date of expiry is not mentioned. Thus the school is required to submit renewed certificate (as per format) issued by concerned Govt. authority with all the necessary details within 03 months and submit the compliance.

- The school has constructed a ramp' 5 to access the upper floors, but it is very steep and does not seem to be navigable by a wheelchair-bound student/staff, unaided. The school has overlaid it over a stair case. Thus, the school is required to construct the ramp/lift to access upper floor and separate CwSN toilets for boys and girls on every floor with proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and Board's guidelines within 03 months and submit the compliance.
- 6 The school is required to submit the appointment letter of the special educator and newly appointed 10 TGT within 03 months in the compliance.
- The school has established the 7 library in the block which is under construction. Thus, the school is required to take the adequate safety measures to ensure safety / protection of the students within 3 months and submit the compliance. Also the students shall not be allowed to venture in other part of the building
- The school shall conduct training of 8 its teachers with CoE Noida within 3 months and submit the compliance
